This letter is in regards to 2287 10th St. the residence of Mr & Mrs Mark Behm. We have resided here for 16 years. When we purchased our home we had all new concrete put in, including a double wide driveway, approach and sidewalks. For years we have been battling with the city over a broken sewer in front of our home. The sewer has never worked. For years, everytime it rained the street would fill with water all the way up to our front porch. We called the City constantly complaining of the problem. They would send out the vector truck to suck up the water and when they drove off the street would fill right back up (enclosed photos). This went on for years. In the winter it was a solid sheet of ice, spring a lake. Mind you in the mean time all our new concrete was submerged in water causing the shifting in the concrete. This water caused sewer destruction, our basement flooded and we had to have the walls waterproof at a very costly expense. After time went by the road began to crumble. They would come out and fill it with black top which would only last a short time until the next rain. In several occasions we would have to call the police because of fear of it causing a serious accident. The street was a mess! Finally this past summer we were put in contact with Gary from the Municipal Service. When he came out we explained about the years of dealing with the problem. They finally fixed the sewer and informed us the road would be repaired this summer. Now we come to the new issue. Recently they came through our neighborhood and marked uneven and broken sidewalks. We are told we have 30 days to obtain a permit and have these corrected or the city will do it for us and we will be billed. We have already paid once to do this if this problem would have been taken care of right away I highly doubt that there would be anything wrong with our concrete. It was all brand new. This is not a money issue on our part this is about principal and integrity. This is absolutely unacceptable and unfair. Enclosed are photos and we have many more from throughout the years. If this mess were out in front of your homes and you had to tolerate the years of mess, would you consider this your responsibility. Where is the compensation for us having to live with this for years. The hours spent on the phone trying to get someone to fix this mess. We have made this our home we have no intentions of leaving. Is this why we pay taxes? With all due respect we hope you can understand where we stand.



PERSONS IN THE AUDIENCE

Jim Zang, 1757 Chestnut, was present and read the following into the record:

June 1, 2009

Mayor Peterson & Council Members,

I'd like to take a few minutes of your time to point out a condition that has troubled our district ever since the passing of Proposal A in 1994. That is the point where our cities school district funding was changed and taken from our control. The initial concept was well received by the public... there would be no more school millage increases to vote on, funding would be provided by the State, and smaller and more remote districts would be better funded.

It sounds good, one less thing to worry about, but after 15 years the problems are starting to show. The same year that we passed proposal A, the voters of our city turned down a local millage renewal. This action had a radical effect in setting our district base funding rate at the minimum level. What this means is that each year, our district receives less money per pupil than our neighboring cities (with the exception of Lincoln Park who receives the same). Less money to provide our children the fundamental skills they will need to flourish and compete in the future, whether they should choose college or directly entering the work force.

Our District as a whole has garnered an exceptional reputation for overcoming this financial shortcoming over the years. Dr. Cole and her administration manage to make lemonade from the lemons they have been given. With rising costs and diminishing income, they have shown constant improvement in the process of educating our children. Their efforts in surviving and overcoming this economic disadvantage have been nothing less than stellar.

Now our district is faced with the necessity of having to close a school, lay-off teachers, and tomorrow evening, will be considering pay-to-play as a requirement to participate in extra-curricular activities. These are issues that directly and immediately affect our community and the intrinsic value that it possesses because of our excellent schools. Yet, our hands are tied, we can't even try to better our own lot in life as a community because proposal A prevents us (but not more affluent districts) from imposing another millage, even if we as a community would approve.

I've provided a chart that shows the disparity between what our districts children receive per pupil, and what the districts surrounding us receive. As you can see, if we were funded at the same rate as Southgate we would receive a little over nine hundred thousand dollars more per year. Several other districts such as Grosse Ile, River Rouge, Trenton, and Dearborn are funded much higher- if our funding were equal to these cities, our district budget would be working with more than seven million more dollars per year and this dialog would not be taking place.

What may inflame this situation even more is that each of these cities pays less in property taxes than the residents of the City of Wyandotte. The second chart shows a few comparable property tax bases for a typical two hundred thousand dollar home with a state assessed value of one hundred thousand dollars. If that typical home happens to be on Grosse Ile you would pay \$661.80 less than if it were in Wyandotte. In short, we as a community are paying more and getting less.

As the state faces its many trials and tribulations in balancing the budget, the funding for our schools on a state level is being considered for additional reduction. I would encourage each of you to use your considerable combined political influence to sway our State Legislature to ensure that if cuts must be made to school funding, that the cuts come from those districts that are funded at the highest of levels until such a point is reached that all of the districts in the state are equal.

A student in Wyandotte is worth just as much as a student in any other district in our state.

Even though there has been considerable effort to remedy the disparity in funding for our district by our specific State Representatives; our state legislature as a whole has chosen to ignore, avoid, or defeat any progress regarding this issue for many years. And still, we have managed to get by through carefully cutting programs and opportunities available to our children.

It is time to stop just getting by.

There is an old saying that a rising tide will lift all boats. Consider this variation on that saying; as that same tide ebbs, will our school district find itself floundering in the mud, forced to devalue itself by jettisoning valuable programs and opportunities just to stay afloat?

Our students deserve equality in funding their education, and our legislature needs to make this a priority. It is up to us as a community to try to obtain the best possible funding for our children. As leaders and representatives of this community, I hope that you will make this issue a priority.

A student in Wyandotte is worth just as much as a student in any other district in our state.

The 48th Annual Wyandotte Street Art Fair will be held on July 8-11, 2009. This letter is sent to request that the Public Works Department be notified to close Biddle Avenue, from Oak to Eureka, for the 2009 Wyandotte Street Art Fair from Sunday, July 5, starting at 12:01 AM through Monday, July 13, 8 AM. North and southbound traffic will be rerouted on Third Street with detours at Oak Street and Eureka, all truck traffic to be rerouted to M-85 (Ford Street) via Eureka or Ford (Northline).

The Chief of Police is requested to apply to the Wayne County Office of Public Service for a road closing permit; he should be designated and authorized to sign said street closing permit document on behalf of the City of Wyandotte. Responsibility for all damage claims which may arise from the road closing must be assumed by the City of Wyandotte. The Fire Department should also be notified of this event to reroute emergency vehicles.

Also, the Wyandotte Street Art Fair would like to request the following:

1. Permission to allow the city sidewalks listed below to be used during the Art Fair only, July 8-11, and by those merchants who are issued permits from the Art Fair Committee:

Biddle Avenue, Eureka to Chestnut Street
Oak Street, Van Alstyne to Third Street
Elm Street, Van Alstyne to Third Street
Maple Street, Van Alstyne to Third Street
Sycamore Street, Van Alstyne to Third Street
Eureka Road, Van Alstyne to Third Street
First Street, Oak to Maple

Further, this permission should extend only to those merchants who have been issued a permit. They are not authorized to sub-contract their space. Enforcement of this policy should be authorized by the Wyandotte Police Department under Ordinance 32-1.

2. Permission to the Wyandotte Business Association for the use of First Street from Elm to Maple Street for the display and sale of handmade craft items as authorized for the WBA and Wyandotte Street Art Fair Committee/Staff and that the Wyandotte Business Association utilize the Parking Lot # 10 on First Street for their crafter parking and that they be allowed to also have paid parking in parking lot # 11 from July 6 through July 13 funds from this lot are to return to the Wyandotte Business Association as approved by the Wyandotte Street Art Fair Committee.

3. The Wyandotte Street Art Fair Committee request that outdoor sale and drinking of all alcoholic beverages be done by licensed vendors which have been authorized by the Art Fair Committee. Enforcement of this policy should be authorized by the Wyandotte Police Department under Ordinance 25-9. It is to be prohibited for any person to bring in their own alcoholic beverages at the Wyandotte Street Art Fair.
4. Permission to utilize the Chase Bank Building Parking Lot, area closest to Third Street, July 7 through July 13, as a parking lot for with a charge for the benefit of the Wyandotte Goodfellows and Old Time Ballplayers.
5. Permission to utilize the waterfront parking lot #1, grassy area, and adjacent between Elm and Oak, for entertainment and refreshment area.
6. Permission to utilize Biddle Avenue, from Eureka to Plum Street, to be utilized as a designated parking area, under the control of the Wyandotte Boat Club, subject to approval and coordination of the Department of Legal Affairs, Engineering Dept. and Police Department.
7. Permission to utilize the open area between Sandy's Shoppe and Frank's Pizzeria, July 6 through July 13, as an additional location for the emerging artist's area for the Wyandotte Street Art Fair.

Re: Establishing an Obsolete Property Rehabilitation District for 81 Chestnut - the Wyandotte Arts Center

Dear Mayor and Council:

The undersigned recommends that the City Council initiate action to establish a single property Obsolete Property Rehabilitation District at 81 Chestnut, under the Obsolete Property Rehabilitation Act (OPRA), Public Act 146 of 2000, as amended.

The Act allows for a reduction in property taxes to encourage rehabilitating obsolete commercial property. Establishing the District is the first step in the process. The next step involves filing an application for an exemption certificate that must be approved by both the Council and the State Tax Commission. The application will include detailed information on the nature and extent of the rehabilitation. Information detailing the property's obsolescence will be submitted by the City Assessor at the time of the public hearing.

If the District is created and a certificate is eventually approved, a tax known as the Obsolete Properties Tax would be levied upon the building for 1-12 years, with the actual duration to be determined by the Council. The exemption would not apply to the taxable value of the land or any new personal property. The City has previously approved 10 OPRA Districts in various locations (see enclosure).

If you wish to schedule a public hearing to consider establishing a District, the following resolution authorizes the necessary actions.

At the May 18, 2009, City Council Meeting you referred the complaints of James Bunning of 464 Cedar, regarding properties on Cedar to the undersigned and the following applies. The City purchased 436 Cedar on January 26, 2009 and 452 Cedar on September 10, 2008. All utilities have been cut and cap and the properties are ready for demolition. The Engineering and Building Department has applied for and received funding from the Downriver Community Conference (DCC), Downriver Area Brownfield Consortium (DABC) for testing and removal of any asbestos in these homes. The DCC has informed us that we were approved and we should be able to start the testing by the end of June. After this testing has been performed, the properties will be demolished.

The Engineering Department and the Department of Public Service will continue to monitor these properties to insure the grass is cut and the property remains secured.

As far as property at 472 Cedar the Engineering Department did make an offer to purchase the property, but the offer was not accepted. This property will require an Upon Sale Inspection and the Engineering Department will monitor this property for compliance with the City Ordinances.
